Position Description

Description:

The Assistant Fire Chief is the second in command of the Fire Department and is responsible for directing the operations, training, and response in the Chief's absence or assisting the Chief. This position primarily supervises Maintenance Operations but is responsible for performing a mix of administrative, professional, and technical duties in support of all fire department functions. Work is performed under the general direction of the Fire Chief.

Duties:

- Respond to fire, rescue and other all hazards incidents as outlined by the District's established response guidelines. Make decisions as to the best method of handling emergency and non-emergency incidents and provide Incident Command for those incidents requiring this level of command. Assist the Fire Chief if present.
- Directly participate in and oversee training and emergency response activities as needed
- Assist to develop and execute long-range plans for the department
- Manage day-to-day operations of the department, ensuring maintenance of fleet, physical plant, and training are complete to ensure operational readiness
- Provide input to annual budgets and execute routine purchasing and oversee large expenditures
- Supervises company officers, training officer, and firefighters to ensure safe and successful operations and delivery of both routine and emergency functions of the department
- Perform public communications and stakeholder engagement activities to further objectives
- Set an example for professional conduct and administration for firefighters
